The meeting was called to order at 7:10 pm. Motion by Knott, seconded by Daugherty, to approve the outstanding bills for October and regular bills for November. Motion unanimously passed by voice vote.

Motion by Gill, seconded by Knott, to table the recommendation regarding the Business Administrator contract. Motion unanimously passed by voice vote.

Motion by Knott, seconded by Kennedy, to authorize the Administration to apply for all pertinent Federal and State grants for the 2021-2022 school year. Motion unanimously passed by voice vote.

Motion by Kennedy, seconded by Mock, to accept the resignation of Amanda Woodring from her position as Secondary Teacher. Motion unanimously passed by voice vote.

Motion by Knott, seconded by Knisely, to approve Agenda Items I.4.a-d. Motion passed by voice vote, with Mr. Knott abstaining on the vote for Danyell Knott as Volunteer (relation), Mr. Daugherty abstaining on the vote for herself as Volunteer, and Mr. Burket abstaining on the vote for Denitia Weyandt as Volunteer (relation). These agenda items are:
